Participant, for herself, her heirs, successors and assigns, understands and guarantees that neither Suhaila International, LLC, Suhaila Salimpour, Jamila Salimpour, Suhaila Salimpour School of Belly Dance, Suhaila Dance Company, Suhaila Repertoire Ensemble, Online Bellydance with Suhaila Salimpour and Jamila Salimpour, Bal Anat, www.therealsuhaila.com, www.suhailainternational.com, Luka Dziubyna, Jamila Salimpour, nor their subsidiaries, affiliates, employers, employees, agents, instructors, subcontractors, representatives, insurers, lenders, officers, directors, members, partners, heirs, successors, assigns and authorized guests may be held liable in any way for any occurrence in connection with any injury, death of other damagers to participant or her family or heirs and PARTICIPANT HEREBY RELEASES AND DISCHARGES FOREVER SAID PARTIES FROM AND AGAINST ANY AND ALL LIABILITY ARISING FROM PARTICIPATION IN THE WORKSHOP whether or not occasioned by the acts of negligence or failure to act of any of the aforementioned persons and whether or not the risk was foreseeable or unforeseeable. Participants further waives as to all such parties all claims and demands arising out of or in connection with the use of photographs, film or tape which may feature participant as otherwise provided herein, including but not limited to, any claims for defamation or invasion of privacy.

Suhaila International, LLC may film the aforementioned workshop. I consent to photography/videotaping (both sound and images) and its release, publication, exhibition or reproduction to be used on Suhaila International's websites,

telecasts, advertising or any other purpose. I waive all rights I may have to any claims for payment or royalties in connection with any exhibition, televising or publication of these materials. All decisions of the arbitrator shall be final, binding and conclusive on all parties. Judgment may be entered upon any such decision in accordance with applicable law in any court having jurisdiction thereof.

If any provision of this agreement is ruled invalid or unenforceable as to any person or circumstance, all other provisions of this agreement shall remain valid and enforceable as applies to all other persons or circumstances.

Participant hereby represents and warrants that she is of legal age and legally competent to sign this Agreement; that she understands it and agrees the terms herein are legally binding and not a mere recital; that she has fully informed herself of the contents of this agreement by reading it before she signed it, and that she signs this document of her own free will.
